EARLY ENTRIES ARE ENCOURAGED. Tournament fees indicated are for all entries received prior to the day of the tournament. Walk-in entries are accepted but bowlers are assessed at the rate of \$5.00 per event per bowler (See Rule 7). Bowlers are not required to bowl in both events.

RULES

1. All applicable USBC Rules will govern this tournament.
2. All SMC USBC members who have bowled a scratch 700 (3 Game) or better series at any time are eligible to enter the Scratch Singles Event. All SMC USBC members who have not bowled a scratch 700(3 game) series in the last four years are eligible to enter the Handicap Singles Event.
3. The Handicap Doubles Event shall consist of an SMC USBC member who has bowled a 700 series and an SMC USBC member who has not within the last four yrs. Handicap for both the doubles and Handicap Singles Event shall be based on 90% of the difference between 220 and each bowler's average.
4. Averages to be used in this tournament (in order of precedence) shall be the bowler's highest USBC league average of last season as listed in the SMCUSBC yearbook. A bowler who does not have an acceptable regular season average may use his/her highest January 1st, 2012 or second their 2011 summer league average. All bowlers who have a sport league average will use the re adjusted average if higher then their standard league average. All others shall bowl scratch. The 10 pin rule (319a-2) and the 15 pin rule (319e) are waived for this tournament. **BOWLERS ARE RESPONSIBLE FOR VERIFYING THEIR OWN AVERAGES IN ACCORDANCE WITH RULE 319A-3.** USBC rule 319d, reporting prior prize winnings has been waived. Tournament director has the right to re-adjust any bowler averages per USBC rule 319c. Any Incorrect Averages, Bowlers in Singles or Doubles will be Disqualified
5. All prize monies will be returned 100%, with a minimum of 1 prize for each 10 entries. The minimum cash prize shall not be less then the prize fee. The association awards committee will determine specific cash prizes after the number of entries are known.
6. The top five (5) finishers in the Scratch Singles Event will be involved in a "stepladder" final to determine the winners of the tournament.
7. Entries will close 30 minutes prior to each squad time. Walk-in entries shall pay an expense fee assessment of \$5.00 per bowler.
8. Dress code: All bowlers must wear a shirt with sleeves. Slacks, Shorts, Skirts & Jeans in neat clean appearance will be allowed. The following apparel is NOT PERMITTED T-shirts, sweats, tank tops, halter-tops or any clothing with inappropriate writing on them.
