QUALIFICATIONS FOR MEMBERSHIP TO THE HALL OF FAME

- An Application for Membership may be submitted by anyone, including the individual who is nominated.
- Applications for Membership must be **received** by the Hall of Fame by September 30 of the current year to be considered for the following year. If received after September 30 the application will be carried over to the next application year.
- Applications may be submitted to any Hall of Fame member. If submitted by mail the date of receipt will determine if the application will be considered for the current year. Applications may be mailed to the Hall of Fame at 13535 5th Avenue Northeast, Bradenton, Fla., 34212 or to the address of any Hall of Fame member.
- All nominees for Meritorious Service and Bowling Performance must have been a member of SMCBA for at least ten years. All nominees for Veterans category must have been a member of ABC/USBC for at least 30 years and may be based on a combination of service and performance.
- Nominees for membership in any category should have the character that is a positive reflection on bowling and on the Hall of Fame. All nominees will be evaluated with regard to their sportsmanship, character, and conduct on the lanes. A nominee's exemplary behavior as demonstrated by these attributes should serve as an example for all bowlers.
- **SERVICE:** Nominees for membership in the Meritorious Service category must have a minimum of 10 years of distinguished service in SMCBA. The service must be above and beyond that ordinarily expected of someone in a similar position.
- **BOWLING PERFORMANCE:** Nominees in the Bowling Performance category must be at least 35 years old unless the nominee is deceased prior to reaching age 35. Honor scores, awards, league average, tournament championships, and local tournament participation will be considered.
- **VETERANS:** Nominees for membership in the Veterans category must have bowled in the ABC/USBC for at least 30 years and must be at least 65 years of age or deceased.
- The Hall of Fame will vote on all qualified nominees in February of each year. A nominee must receive "yes" votes from at least 75% of the active members in attendance at the February voting meeting to be elected to the Hall of Fame.
- Any nominee who does not receive sufficient votes to be elected may resubmit the application to be considered for the following year. If a candidate receives at least 50% "yes" votes, the application will automatically carried to the next year.
